Good News! Starting from 14 December, inbound travellers are no longer required to undergo the "0+3" medical surveillance period*, and are free to enter restaurants, gyms and beauty parlours once they landed by presenting vaccination records!

SME Export Marketing Fund 中小企業市場推廣基金

SME Export Marketing Fund (EMF) has been expanded to cover large-scale exhibitions targeting the local market as well as online exhibitions, and the eligibility criteria has been relaxed to cover non-listed enterprises till 30th June, 2026. Cumulative amount for each enterprise has been increased from HK\$800,000 to HK\$1,000,000. Eligible Hong Kong exhibitors may apply and to save up to 50% exhibiting costs!
